PRIVACY NOTICE ON THE PROCESSING OF PERSONAL DATA IN THE CONTEXT OF PARITICIPATING IN ONASSIS SCHOLARS ASSOCIATION

We, Alexander S. Onassis Public Benefit Foundation Scholars' Association, established in Athens, Greece (4 Aeshinou Street 10558) ("the **Scholars' Association**") and ARIONA HELLAS S.A., a company established in Athens (at Evridamantos Str. and 2 Galaxia Str.) acting as representative in Greece of Alexander S. Onassis Public Benefit Foundation ("**Ariona**" and jointly with the Scholars' Association "**We**") will collect as "joint controllers" the information that you provide to us ("**Data**") in the context of your participation in and the operation of the Scholars' Association in accordance with the provisions of the applicable legislation (EU General Regulation 679/2016, Law 4624/2019 as in force) and the decisions and guidelines of the competent supervisory authority.

We are committed to respecting and protecting the privacy of our members, directors, partners, participants in our activities and we are obligated to inform you in a transparent way of the respective processing of your personal data.

We reserve the right to amend and update this Privacy Notice whenever necessary. If there are any changes to this Privacy Notice, we will make available the new document on our website and on our Scholars' Association Member Guide, by informing you accordingly. Therefore, we recommend that you carefully read this Privacy Notice and also check our webpage periodically.

By filling out and submitting your participation in the Scholars' Association or in any of its activities or in a respective collaboration you acknowledge and accept our right to process the information related to you and/or your child in the manner that we describe here and in any respective specialized privacy notices.

1. What personal information do we collect?

We collect only the information that is necessary and is identified in our constitutional documents or in documents that we provide to you or in any supplementary documentation thereof, and in general in the context of our relationship with you, namely:

- Basic identification data (such as name, surname, address, date of birth)
- Contact details (such as telephone, email)
- Information relating to your profession (such as business industry, business address, area of activity)
- Information regarding your capacity and your activities as member of the Scholars' Association (such as time that you started and ceased to act under the particular capacity, participation in events, open calls or administrative or other offices, financial obligations towards the Scholars' Association, any produced work, proposals for actions)
- Image and presence in general (such as in the context of our actions during which a photo-shooting or videorecording takes place)

- Information regarding your attendance or participation in our events (such as participation declaration, any submitted works, expenses' payments)
- Data that relate to a collaboration with us (such as duration, subject, respective contracts).

We note that in certain activities and/or events that may be performed either with physical presence or remotely via an electronic mean (such as videocall) or with both methods available, there may be recording of image and/or sound or live broadcasting of the event through our means or of that of designated third parties. For more specific information on the processing that we perform on such occasions, please refer to the respective privacy notices, as available along with each specific announcement.

We do not collect data of special categories. In exceptional and individual cases where is necessary due to the specific circumstances of the relevant action (such as information on the existence of any special needs or nutritional restrictions that may affect your participation in an event) we may collect such data as long as we have your consent, unless the processing of such data is performed on another legal basis such as compliance with an obligation we may have under law or where you have already made this information public or if necessary for the performance, with the appropriate safeguards, of our legitimate activities that relate exclusively to our members.

To the extent that you provide any information or works that may identify your child, who wishes to participate in any of our events with your approval, we ask beforehand that the relevant participation documentation is duly filled out, signed and submitted to us by the persons with parental rights and responsible for the child's care.

Should you provide to us information of third parties (e.g. of related professors, of the person accompanying the child during the event) you undertake and warrant that you have performed all necessary actions in order to lawfully collect and transfer to us these data, including disclosure of this notice to the said natural persons.

2. How and why do we process your data?

We will process the Data so you can become a member and participate to the Scholars' Association actions and events and in general for the purpose of managing and organizing the Scholars' Association's activities.

In this context, the Scholars' Association will process your information initially to assess and manage the relevant membership registration process, and further to ensure that you are able to participate in its activities. The Scholars' Association will use the information that is necessary so to comply with the relevant procedures that it has adopted and applies in accordance with its constitutional scopes and applicable legislation, such as so to verify settlement of registration fee and any other due amount, elect its administrative bodies, approve proposals, provide information of coming events, conduct research, cover expenses relating to scientific publications of its members etc. The Scholars' Association will record

the information that relates to the membership also for historical purposes, as it does for all its members.

In parallel, we as Scholars' Association will keep the Data, as we do for all our members, to abide by our legal obligations and, where necessary, for the exercise of our legal rights.

Ariona processes the Data primarily for the purpose of fulfilling its obligations that arise and/or are related to its collaboration with the Scholars' Association namely to arrange for any funding requirements or to administer events organized by or jointly with the Scholars' Association. In this respect, Ariona will use your contact information to fulfill its respective legitimate interest relating to the promotion to the respective members of events organized either jointly with the Scholars' Association or separately by Ariona.

In any event where there is recording of sound/image we will present any produced material, upon your consent unless you have otherwise granted us any intellectual property right, to the public in the context of our activities and actions with means of our choice, such as, through our websites, social media, publications, mass media or even online platforms such as YouTube.

In case you need to disclose to us some health condition related to you and/or your child, such as allergy, special need etc., as this may be necessary in the context of your participation in an event (such as e.g. a sport event), we will request your explicit consent for doing so.

In case we do not receive all the information that is deemed necessary, we will not be able to fulfill the purposes that we describe herein and thus not be able to verify your membership at Scholars' Association or to include your participation (or of your child, where this option is available) in a particular event / procedure of ours.

We wish to inform you that we will keep your contact details (email), as long as you do not declare that you disagree, in order to send you newsletters for our events and up to the submission by you of an opt- out request, which you may be able to make at any time. For clarification purposes, the opt-out request will not apply to use of these data for contacting you regarding a matter that relates to your membership namely to any obligations or rights in the context of the Scholars' Association constitutional procedures, or to your contractual obligations (such as for example in order to inform you of any outstanding payments, or in the context of the election process of an administrative body of the Scholars' Association or to abide by an agreement with us).

3. Who has access to your information and how do we safeguard this access?

The said personal information will be maintained and processed for the above purpose by our competent departments and personnel that handle the operation of the Scholars' Association, the promotion and communication for our activities.

Additionally, the Data will be processed by authorized third parties with whom we may cooperate for the realization of our activities (such as indicatively, and depending on the case, photographers, travel agencies, ticketing systems administration providers, technical services providers) who, insofar as they act as "processors", will be bound by a confidentiality and other obligations by virtue of a written agreement or other legal act exclusively so to provide their services to us and not for their own benefit.

Moreover, in cases where an event is realized jointly or in collaboration with another organization or competent authority, the latter may have access to that information that is necessary in the context of this collaboration depending on their respective role (if they also act as controllers). For more specific information on the processing that we perform on such occasions, please refer to the respective privacy notices, as available along with each specific announcement.

4. How long do we maintain your data?

We will collect and maintain the said data only for the time necessary to fulfill the purposes that we identify herein.

Such retention period may vary depending on the case. For example, your information will be maintained for the whole membership period or for as long as any collaboration between us remains in force. After such period we will keep that information necessary to comply with our legal and/or contractual obligations, such as for as long as the relevant copyright license on any produced materials granted is valid, taking also into account the applicable legislation's requirements, statute of limitation time periods for exercise of our legal rights.

In each case and especially if we maintain the Data for a time exceeding the membership period, as for example for historical purposes, we will apply appropriate technical and organizational measures (such as anonymization, pseudonymization) to ensure the minimization of data collection and the appropriate security level of the particular data processing operation.

5. What rights do you have?

You have the rights that are attributed by law, subject to the applicable legal terms and conditions, and more specifically:

- The right to request access to your data that we keep and receive a copy of your data
- The right to request rectification of inaccurate or incomplete data that we maintain related to you
- The right to request the erasure of your data that we are no longer entitled to keep
- The right to object to the processing of your data that is based on our legitimate interest
- The right to request the restriction of processing
- The right to data portability, i.e. to request that we provide you or another controller with your personal data in a structured, easily readable format (e.g. USB)

• The right to revoke your previously given consent, where the processing is based on your consent. Where the Data processing is based on your consent, you are entitled to withdraw your consent at any time. The withdrawal of previously given consent will have effect only for the future and any processing based on such consent will remain lawful until the time of its withdrawal. We will be entitled to keep and process those Data that are necessary, even after the withdrawal of your consent, to the extent required or otherwise permitted by law and in particular for us to comply with our legal or regulatory obligations and/or exercise and defend our legal rights.

If you exercise any of these rights, we shall undertake all necessary measure to satisfy the relevant request within the time limits set by the law (one month that may be extended for another two months in case it is necessary due to the complexity or number of requests), by notifying the particular applicant/Scholar respectively in written of the satisfaction of the request or alternatively the reasons that prevent the exercise of such rights or satisfaction of such request. Please note that the exercise of the above rights is subject to certain prerequisites and limitations set by law. For example, we may not be able to respond to a request if we do not receive the identification information that is deemed necessary so to ensure the protection of your personal data and to confirm that it's you who makes the request, or to delete information that we are required to maintain so to comply with a legal obligation or to pursue our legitimate interest.

In the event that you disagree with the data processing that we perform and/or with our response to a request, you are entitled to address a request to the competent supervisory authority (Greek Data Protection Authority), which reviews written complaints within its competency in accordance with the instructions provided for in its website (www.dpa.gr).
