DETAILED TERMS AND CONDITIONS FOR PARTICIPATION IN THE PRIZE DRAW

FOR A PRIZE OF 250 DOUBLE INVITATIONS FOR ONASSIS STEGI PRODUCTIONS

1. DESCRIPTION OF THE PRIZE DRAW

The company under the corporate name "ARIONA HELLAS SOCIETE ANONYME ARTISTIC AND CULTURAL EVENTS TECHNICAL AND CONSTRUCTION," with registered seat in Athens, 2 Galaxia & Evridamantos Street, Tax ID No 099731160, Tax Office KEFODE ATTIKIS, and General Commercial Registry (GEMI) No 122001701000 (hereinafter the "Company"), owner of Onassis Stegi (cultural center located at 107–109 Syngrou Avenue in Neos Kosmos) as well as Onassis Ready (exhibition space located at 2 Strati Tsirka Street in Agios loannis Rentis), organizes a Competition (hereinafter the "Competition"), which will take place exclusively for new account holders at Onassis myaccount within a specified time period, offering as a prize 250 double invitations for productions (performances and exhibitions) of the Company, as further defined in term 4 herein.

The purpose of the present detailed terms and conditions (hereinafter the "**Terms and Conditions**") is to set out the terms and conditions of participation in the Competition and the procedure for selecting the winners within such.

The Company reserves the right to unilaterally amend these terms, extend or shorten the duration, and/or cancel the Competition, as well as amend and/or replace or revoke the prize of the Competition, as defined herein, for any reason and/or without cause and at any time through a relevant message from infotickets@onassis.org or through an announcement at www.onassis.org. Any such amendment shall be binding upon every participant. The Company assumes no responsibility arising from the above amendments.

2. DURATION

The Competition shall run from 04.12.2025 at 12:00 p.m. until 11.12.2025 at 12:00 p.m. (hereinafter the "Duration").

3. PARTICIPATION & NOMINATION PROVISIONS

Every natural person who is at least 18 years old, has full legal capacity at the time of participation, and resides in Greece is eligible to participate in the Competition. Excluded from participation are: (i) employees of the Company and their spouses, and (ii) first-degree relatives of the aforementioned employees.

To participate in the Competition, each person (hereinafter the "Participant") needs to create a new electronic account at Onassis myaccount [(https://myaccount.onassis.org/) hereinafter the "Account"] within the Duration of the Competition, as defined in term 2 hereinabove.

Upon successfully creating the Account, the Participant will be automatically entered into the draw from which the Competition winners will be selected, and will receive a confirmation email to that end within two (2) working days. If the Participant does not complete all steps of the Account creation process, they will not be entered into the Competition.

Participation in the Competition implies full and unreserved acceptance of all the present Analytical Terms, as posted on the website of Onassis Stegi (www.onassis.org) and included in a relevant newsletter sent to registered Onassis Stegi Friends.

The draw will be conducted electronically on 12.12.2025 at 12:00 p.m. via the <u>www.random.org</u> system. Two hundred and fifty (250) winners and fifty (50) alternates will be nominated during this process.

The alternates will be notified in the order of the draw if any of the initially selected winners decline or fail to accept the prize in accordance with the above.

Only valid participations will be considered in the draw. A "valid participation" is one that cumulatively fulfills the following: (i) it has been submitted in accordance with the procedure described above; (ii) it is not, in the

Company's judgment, the result of illegal activity or fraud or unfair technical intervention by the Participant or by any third party; and (iii) it has been submitted within the Duration of the Competition as defined in term 2 hereinabove.

The Company reserves the right to cancel any participation that does not comply with these terms.

4. PRIZE

5. COLLECTION OF PRIZE

The winners of the draw will be notified by the Company's representatives via email (and in case that is not possible, through phone call) within two (2) working days from the draw (using the contact details provided by the respective

Participants in accordance with these terms) for them to accept, if they wish, the Prize. The Company shall not be liable for the accuracy of the information provided by the winners. Following this communication, the winner must contact the Box Office of Onassis Stegi by telephone within five (5) working days at ++30 219 219 1000, stating the details with which they created their Account (full name, email) so that the reservation can be finalized and the invitations can be issued, which will be received by the winner electronically via email. Should any of the winners fail to contact the Box Office of Onassis Stegi by telephone to redeem the Prize within the timeframe above, that person will be excluded from the Competition, and the Company shall be released from any obligation towards that specific Participant.

6. RESPONSIBILITIES / LIMITATIONS / LIABILITIES

Participation in the Competition requires access to the internet using the Participants' own technical means. The Company and its subcontractors are not responsible for ensuring or assisting with Internet access, or for providing any related technical support to the Participants. Access to the Company's Account-creation system is permitted only under the operating conditions of the relevant server and the technical specifications of the Competition.

The Company shall not be liable if, for any technical reason relating to the Participant's own systems, the creation of an Account (and therefore participation in the Competition) is impossible, nor for any direct or indirect damage arising from participation in the Competition due to slight negligence, accidental events, or force majeure.

7. CANCELLATION OF PARTICIPATION

Participation of any winner or alternate may be canceled at any stage, even at the stage of prize delivery, even without prior notice, for the following reasons:

- (i) if the Participant, for any reason, does not fully and unreservedly accept all the present terms and conditions, all of which are considered substantial:
- (ii) if the Participant does not accept or accepts the Prize with a delay;
- (iii) in case of inappropriate behavior.

In case of cancellation of any winner's participation, their right to the prize will be automatically transferred to the following alternate, according to the order determined by the prize draw.

8. PERSONAL DATA

By submitting a participation request in accordance with these terms, the Company may process the Participant's personal data, taking all appropriate technical and organizational measures to ensure confidentiality and security of processing, as specified herein.

For the purposes that are identified herein, the Participant's Data shall refer to the personal data which are necessary so that the Participant takes part in the Competition (basic identification, contact details, information relating to the participation in the Competition) and which are provided by the Participant in the context of their

involvement, as these are described in the present terms or otherwise arise and/or are connected with the Competition (the "**Data**").

The Company will process the Data to manage the participations and implement the terms of the Competition (including verifying the identification information by opening the Account), but also to publicly promote the Competition using its chosen means for so long as it has the right under Law. In this context, the Company will process the information provided by the Participant for registration as an Account holder, for the purposes of administering such Account and offering the services set out in the respective terms of use that the Participant accepts, and until the deactivation of the Account.

The Company will not disclose the Data of the Participants to any third party, unless otherwise described herein. The winners' data deemed necessary for the organization of the Competition and for sending the Prize will be transferred by the Company to third-party collaborators involved in implementing the Competition.

The Data will be maintained and processed by the Company's competent departments and personnel, with duties including organizing and presenting the Competition and its events, as well as administering the Onassis Account. For the realization of the Competition, the Company may, under the terms of law, assign to third parties, collaborators, the execution of specific processes of the Data (e.g., technical solutions providers). Insofar as such third parties act as data processors, they shall be bound by a written contract or other legal act to the confidentiality obligation and shall process the Data exclusively to provide services to the Company.

The Data will be kept for the whole duration of the Competition and the participation of the Participant in relevant events, if any, for the purposes described herein. The Company will maintain the Data after the Competition for the time necessary for the fulfillment of the purposes for which the Data were selected, as provided herein, in compliance with the Company's contractual (for as long as the Account is active) or legal obligations, but also so long as the Company assumes any related right (for example, to archive the information relating to its events) taking into account the requirements of applicable law and the statute of limitation periods for performing legal actions.

The Participant is entitled to exercise all the rights provided in the applicable legislation (primarily the Regulation 2016/679), under the terms and conditions set therein (and more specifically, the right of information regarding the Data that are subject to processing by the Company; the right to access such Data; the right to rectify or erase the Data; the right to object and restrict the Data processing; the right to Data portability to another Data controller or processor; the right to recall a previously given consent—where the processing is based on the Participant's consent), and any other recognized right. It is noted that the withdrawal of previously given consent will have effect only for the future and any processing based on such consent will remain lawful until the time of its withdrawal. In case of exercise of such rights, the Company will take any necessary measures to satisfy the relevant request within time frame provided by the Law (i.e., within 30 days, which may be extended for another two months), and will notify the Participant in writing regarding the satisfaction of their request, otherwise regarding the reasons preventing the exercise of such right or its satisfaction. The Participant shall exercise such rights in writing by sending the relevant request to the email address gdpr@onassis.org.

Moreover, in the event of an objection to the processing of Data by the Company, the Participant reserves the right to address relevant requests to the competent supervisory authority (Personal Data Protection Authority), which handles written complaints in accordance with the instructions available on the website (www.dpa.gr).

9. MISCELLANEOUS

After the expiration of the Duration of the Competition and the receipt of the Prize, or the lapse of the deadline for receipt of the Prize as mentioned hereinabove, any obligation of the Company in the frame of the present shall cease to exist. The Company shall not bear or assume any further obligation towards the Participants relating to the Competition.

The Participants do not have, and do not acquire, any right over the trademarks, trade names, names, indications, emblems, and other distinctive signs of the Company and/or Onassis Stegi, and the other companies collaborating with them.

If any provision of these terms becomes invalid, remaining terms shall remain valid, and the rest of the terms shall remain in full force and effect.

Any dispute that may arise in relation to the Competition and the application of these Analytical Terms shall be interpreted in accordance with Greek Law and shall be resolved by a three-member Committee exclusively appointed by the Company. The Committee's decision in such cases shall be binding upon the Participants.
